

Model Release TF/TEST

This document constitutes a binding contract between Jane Doe and Thomas Holm regulating the ownership and use of photographs and derivative works based thereupon (collectively hereafter the "Photos") taken by Photographer Thomas Holm of Model Jane Doe on this particular session Demo Model Release for all lawful purposes, subject to the terms and conditions described below.

The basis for this contract is a non-commercial arrangement where Model in the interest of gaining modelling experience & exposure and expansion of portfolio, agrees that in exchange of modelling time, Model shall receive processed photographs delivered to Model by Photographer in the quantity and format described as follows:

Photographers obligations Raw Gallery

Within a period of 2 weeks after 30/10/2018 Thomas Holm will make available a raw, unedited online gallery consisting of the best images from the shoot. This gallery will be the base material for further selection for the final images by the photographer. Model can eliminate up to 10% of the images in this gallery in case some of them by Model are deemed undesirable for publication – this must be done within 2 weeks after receiving access information to the raw gallery. Elimination of images should be done by sending the image name ("model_name_dd_mm_yy-xxxx") to photographer via E-Mail. In addition model are welcome to 'Like' and Comment on images. When selecting the final images for processing, If Thomas Holm is in doubt between several images, the models comments and likes will be taken into account.

Images

A minimum of 3 processing pictures will be made available to Jane Doe each in 3 different sizes ranging from 2048px on the longest side to 900px wide supplied in JPEG format, and made available for download online via dropbox or similar service, or delivered via email.

Delivery shall take place in a timely manner but no later than 30 days after model have communicated images to be eliminated or no later than 60 days after (Shoot.End Date)), unless otherwise agreed in advance of shoot. Photographer may at his discretion choose to process more than 3 images, and if so delivery of these will be whenever images have been processed at a later date.

Prints

In addition, Model can choose 1-2 of the edited images and have up to fine-art 2 prints made in a size up to 40x60cm. Production time of prints may take an additional 4 weeks to produce and send. This delivery constitutes the whole obligation of Thomas Holm towards Jane Doe.

Photographers rights of usage:

A. All purposes related to the promotion of Photographer's photography business, including, but not limited to: Advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites and in addition inclusion in photography books for both print and e-reading and as fine-art prints offered for sale.

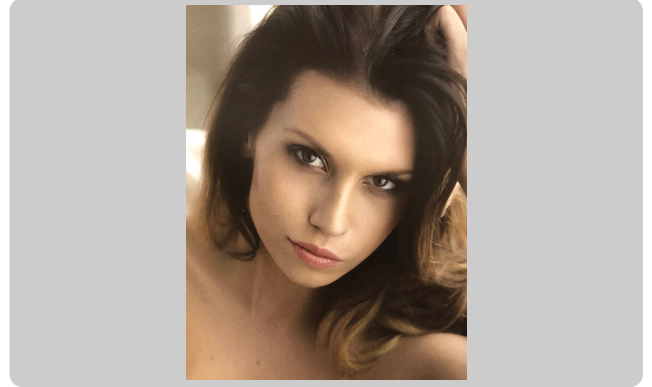
B. The photographer may sell or transfer rights to media sources, such as but not limited to: Online Magazines, printed Magazines, newspapers, newsletters or television or other media as editorial or news, related to the theme, or themes, of a photo shoot, photo session, series of images or individual image as long as the photographer provides the model full model credits.

Model rights and obligations:

1. Model agrees that copyright, moral rights, and all other intellectual property rights to the Photos belongs to Photographer and/or his or her heirs, licensees or assigns, with full right of lawful disposition in any manner. Photographer should be credited as 'Thomas Holm Photo', and may be tagged on social media as @thomasholmphoto

2. Model agrees that, while he/she may use the Photos for purposes related to the promotion of Model's modeling business, including, but not limited to: Advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites, Model will not sell or otherwise transfer publication rights to any of the Photos without Photographer's prior consent. Images may be used on sites such as Patreon, Onlyfans and similar without requiring further permissions.

Model agrees that the Photos shall not be cropped, altered or distorted in any way when they are used to promote Model's modelling business, except for purposes of censoring to comply with guidelines prohibiting nudity. Any watermark and copyright notice that appear as part of a Photo must be left intact.
5. Model releases and agrees to hold Photographer and/or his or her heirs, licensees or assigns, harmless from any claim or liability in connection with the publication or use of these images in any manner or form whatsoever, unless it can be clearly shown that the foregoing was maliciously caused, and produced, and published solely for the purpose of subjecting Model to conspicuous ridicule, scandal, reproach, scorn, and indignity.
6. Model hereby affirms that all poses, positions and situations enacted in the Photos covered in this release were entered into without force, coercion, or threat whatsoever, and were posed freely by Model with Model's full consent. Model further agrees to hold blameless and free of all accusation of such force or coercion Photographer, his legal representatives, assigns, and those acting under his permission.
9. Model hereby affirms that Model is fully able to contract in his/her own name without breach of any prior agreement or applicable law, including, but not limited to, prior agreements with modeling and talent agencies.
10. Model wishes to be credited with her stage name Stellar as mentioned elsewhere in this agreement. If no stage name is written in the agreement model will remain anonymous.
11. Both Model and Photographer affirms to have read the foregoing prior to its execution and agree to the contents thereof.
